Vide the above referred Circular dated April 29, 2022, it was communicated that *All 1855 Retail Branches to be kept open and dealing teams of RPU, CPU-Capital Market Operations and Capital Market HO to be functional on Sunday, May 08, 2022 for any support. From May 04, 2022 to May 09, 2022 (on all days including Bank Holidays, all Branches to accept customer application till 7 p.m. and till the cutoff time on the last day).*

2. May 08, 2022 is Sunday and May 09, 2022 is a Holiday in West Bengal State on account of Birthday of Rabindranath Tagore. Keeping in view of **large number** of Officers working across the Country on Sunday/Holiday, we respectfully request your goodselves to issue Head Office Circular permitting the Officers working on Sunday/Holiday for LIC IPO to avail Compensatory Off **within one month** (*instead of normal stipulation of one week*). We wish to bring to your kind notice that in case of working on holiday on account of year end annual closing activities in March, 2013 and March, 2014, the Bank had issued **similar instructions** vide the above referred Circulars dated March 25, 2013 and March 27, 2014 respectively.

3. In this connection, we also request your goodselves that the Officers who are on sanctioned leave from May 04, 2022 to May 09, 2022 and applied for leave during the same period **prior to** issuance of the referred Circular dated April 29, 2022 should be **exempted** from working on Sunday/Holiday.
