Sub:- Intimation of launch of agitation program for fulfillment of long pending demands - Reg., Ref:- Our Letters dated February 20, 2024, July 15, 2024 and August 03, 2024 to the Bank

The Officers' Body of the Bank, i.e., "All India IDBI Officers' Association" has been **respectfully** requesting your goodselves vide the above referred letters for addressing the below mentioned:

- (a) Payment of balance arrears for the period from Nov., 2022 to May, 2024 (9th Joint Note for Officers).
- (b) Issuance of Head Office Circular on option for **resigned employees** to join **Pension Scheme** along with issuance of **Public Notice** in leading daily newspapers in this regard as well as **individual** intimation to eligible resigned employees (Point No.14 of the 9th Joint Note for Officers IBA).
- (c) Existing limits of Lease Rentals of May, 2019 should be revised with a minimum enhancement of 75% on the existing limit for various classification of Centres i.e., Class 'C', 'B', 'A' and A+ for Officers in all Grades. For Centres like Delhi and Mumbai, there should be a minimum enhancement of 100% on the existing limit for Officers in all Grades. The limits offered to the Officers in Grade 'C' should not be same as the limits offered to the Officers in Grade 'B' as the Officers in Grade 'C' deserve higher limits than the limits offered to Officers in Grade 'B'.
- (d) Introduction of **Furniture allowance** for all the Officers working in the Bank in line with Industry level practices as prevailing in many Banks.
- (e) **Issuance** of Head Office Circular on **revised** Medical Schedule of the Bank along with **display** of the item-wise details on Bank's Intranet.
- (f) **Toxic** work culture prevailing in the Bank coupled with **shortage** of **confirmed** staff at RBG Branches.
- 2. **Despite** numerous representations and discussions, our concerns remain unaddressed till date. We have been patient and co-operative, but the lack of progress has left us no choice but to resort to **agitation**.

We hope your goodselves will understand the gravity of the situation and take necessary steps to address the concerns as mentioned above from Point No.(a) to (f) on or before **September 10, 2024**, **else** the Officers' Body of the Bank, i.e., "All India IDBI Officers' Association" will be **compelled** to take the extreme step of issuing a Circular to its members on September 11, 2024 launching the **agitation program** and **other industrial actions** besides seeking support from other fraternal Bank Unions/Associations due to Bank's inaction on our long pending legitimate demands.
