Sub:- Request for issuance of H.O. Circular and release of revised Bank's Medical Schedule - Reg.,

While the Officers' Body of the Bank, i.e., "All India IDBI Officers' Association" **thanks** your goodselves for the above referred ticker communication dated January 11, 2024 mentioning the revision of the Bank's Medical Schedule, it submits the following **concerns** expressed by the members of the Association:

- 1. Non-issuance of Head Office Circular:** Even though it is **more than one month** from the date of your Ticker communication, Head Office Circular has not been issued by the Bank till date on the revision of the Bank's Medical Schedule resulting in **non-confirmation** of your communication. Your Ticker communication was displayed on Intranet for few days and later the same was removed from Ticker. Since then your communication is not available on Intranet. Issuance of Head Office Circular by the Bank on the revision of the Bank's Medical Schedule will facilitate confirmation of your communication.
- 2. Non-display of revised Bank's Medical Schedule on Intranet:** As on date, on the Bank's Intranet under APU Department – Information and Guidelines – Staff – Bank's Medical Schedule, the old Medical Schedule of 2012 is only being displayed leading to **confusion** in the minds of the employees of the Bank w.r.t. the revision of the Bank's Medical Schedule as communicated by your goodselves. Non-display of revised Bank's Medical Schedule on Intranet is also leading to **denial** of right to information and may give scope for **favoritism** and **nepotism** while processing of the medical claims submitted by the employees.

We **respectfully** request your goodselves to arrange for (a) immediate issuance of Head Office Circular on the revision of the Bank's Medical Schedule along with display of revised Bank's Medical Schedule on Intranet and (b) to make the revision **with effect from April 01, 2023.**
